1. Lessons learnt form the INTOSAI Donor Coordination Group

Dominic Bourcier (Canada) introduced the **INTOSAI** (International Organization of Supreme Audit Institutions) **donor cooperation group** that seeks to enhance the capacity of Supreme Audit Institutions in developing countries. The INTOSAI donor cooperation group organises the Global Call for Proposals (GCP), which facilitates the matchmaking of donors and partner countries by providing the opportunity for all SAIs and INTOSAI bodies to put forward capacity development funding proposals at the country, regional and global level which it then seeks to match with donor and / or INTOSAI funding.

It was discussed how the 'Global Call for Proposals' approach could be applied for ATI partner countries and their need of DRM reform. Participants agreed that such a tool should avoid donor shopping, implement review mechanisms and facilitate ownership of the projects within the partner countries. Later in the session, it was agreed to review the proposed funding template and conduct a study on donor coordination concerning DRM reform.

2. ATI funding template

Tobias Fleckenstein (ITC) presented a draft **funding template** for DRM related projects that could improve the match of demand and supply with regards to technical assistance projects. The funding template could serve as an instrument for partner countries to request technical assistance to overcome specific gaps within their tax policy and tax administration.

It could either be uploaded on the DRM Database or being shared with ATI development partners. In the following discussion, it was mentioned to have the funding template signed by the highest level of the respective tax authority (e.g. Commissioner General) to secure ownership of partner countries. Concerns were raised that a funding template could create an excess in demand of technical assistance projects.

3. DRM Database

Afterwards, the group discussed on the further development of the **DRM Database**, which provides an overview of all technical assistance projects carried out worldwide to support DRM in partner countries. It was highlighted to focus on the improvement of qualitative information like project descriptions and country pages.

4. Oxfam paper on “Doubling down on DRM”

Nathan Coplin gave a presentation on the Oxfam **paper on “Doubling down on DRM”** highlighting the need to incorporate equity, fairness and transparency into DRM related technical assistance projects. For 2016, just a few projects address these issues because these factors are either not a priority or project descriptions in the DRM Database are not properly filled in.
