Objectives

As a follow-up of the <u>webinar on the FTA Digital Transformation Maturity Model (DTMM)</u> held in March 2022, in which the OECD's Forum on Tax Administration (FTA) presented the DTMM, with some practical insights on its application from the Armenian revenue administration, the Secretariats of the Addis Tax Initiative (ATI) and the FTA are organising a virtual workshop series for revenue administrations from ATI partner countries that confirmed their interest in implementing the DTMM.

The aim of the workshop series is to **support revenue administrations in their process of digitalisation and digital transformation** by encouraging and enabling them to use the DTMM for self-assessment, as this may give them a better understanding of their digital maturity and support them in shaping their strategy for digitalisation and digital transformation.

This workshop series is also the result of the discussions held during the first webinar, in which ATI partner country representatives highlighted their interest in this topic, while sharing that one of the main challenges connected to the digitalisation path of revenue administrations is the need to develop a digital strategy that builds upon a network of government institutions. The workshops also build on the ATI Commitment 1, which seeks to "improve the efficiency of revenue administration [...] in partner countries through further modernisation (e.g. digitalisation) and broader institutional change."
